Having acquired an instrument signed by a majority of the lots the following amendments to the protective covenants of Cascade Addition, Norman, OK 73072 are recorded:

1. A Cascade Homeowners Association is to be formed effective September 1, 1990. The said Association will be a not for profit organization designed with the following purposes:
  - a. Maintenance of the entrance easement and other community easements.
  - b. Promotion of community activities.
  - c. Enforcement of Cascade Addition protective covenants.
2. The Cascade Homeowners Association will consist of five directors to be elected by the homeowners in Cascade Addition with each lot having one vote.
3. The Cascade Homeowners Association will have the right to asses dues in the amount of \$30.00 per year to all lot owners. This dues may be increased by said association with the approval of two-thirds of the community lot owners.

Executed at Norman, Oklahoma, this 27th day of August, 1990.

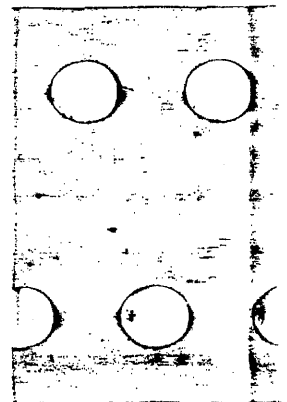
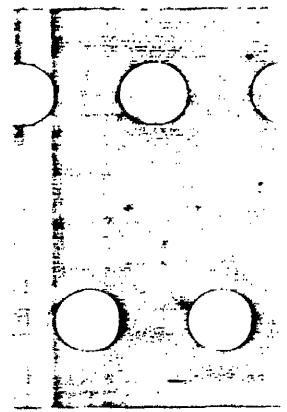
