**NOTICE OF ASSIGNMENT OF DECLARANT RIGHTS

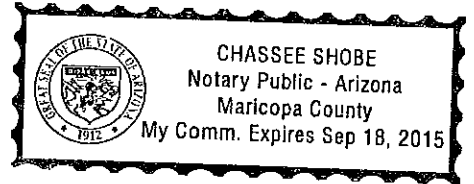
